AcademyHealth's Disability Research Interest Group (DRIG) is composed of researchers interested in the relationships between health policy, care coordination, quality improvement, support services, assistive technology, and environmental changes for people with disabilities and chronic illness.

The DRIG brings together a community of researchers, practitioners, and people with disabilities to share research on disability policy and practice in the U.S. and abroad. The DRIG invites abstract submissions for the June 2018 DRIG research meeting and welcomes a broad range of papers such as improving coordination of services, disability policy, health service use, and quality of care for people with disabilities.

A major theme of the 2018 DRIG meeting will be improving our understanding of how policy affects healthcare access and use for persons with disabilities, and how health service use, in turn, affects health outcomes, independence, and employment. An illustrative sample of presentation topics from recent years is included below to convey the breadth of research that DRIG attendees conduct.

- Medical Homes: Access and outcomes for children & adults with disabilities.
- Health care use patterns, volume, and out-of-pocket spending trends for working age adults with disabilities dually enrolled in Medicaid and Medicare.
- Maternal and child health: Racial and ethnic disparities in birth outcomes among women with intellectual disabilities.
- The Affordable Care Act Medicaid expansions and applications to federal disability programs.
- Using the American Community Survey disability data to improve Behavioral Risk Factor Surveillance System Accuracy.
- Employment experiences of young adults who receive SSDI benefits using qualitative interviews.

- Alternative benefit designs in public programs or private insurance markets which improve quality, contain costs or incentivize changes in behavior by consumers, providers and health plans.
- Relationships among coverage levels, access to care, and individual and population health.
- Impact of ACA outreach, education and marketing campaigns on coverage.
- Studies that encompass overarching topics (see below).

# Payment Reform/Incentive Realignment:

- Potential policy levers available to states to facilitate the implementation of new payment models.
- Policy and implementation issues related to decisions around structuring various payment methodologies including episode/condition-based bundled payment, a shared savings payment model, and total-cost-of-care payments.
- Early lessons from state-level payment reform models, including state-private collaboration.
- Lessons learned from Medicare/Medicaid duals alignment demonstrations.
- Development and implementation of quality metrics that should be included in a new payment structure to ensure provision of appropriate levels of care.
- Policy, process and implementation issues related to facilitating multi-payer payment reforms.
- Development and implementation of payment and incentive options to decrease rates of preventable admissions/readmissions/emergency room use or incentivize other desirable outcomes.
- Lessons learned from State Innovation Model (SIM) or other CMMI grants.
- Studies that encompass overarching topics (see below).

# **Delivery System Transformation/Quality Improvement:**

- Strategies to improve the efficiency and effectiveness of primary/preventive care, chronic care management, and care coordination (e.g., medical homes or other models of improved primary care delivery, integrated care delivery models, ACOs).
- Innovations designed to improve patient safety and reduce medical errors.
- State strategies to better integrate behavioral health services with physical health.
